The **Republic of Tajikistan** has received financing from the Asian Development Bank (ADB) toward the cost of **Skills and Employability Enhancement Project (SEEP)**, and it intends to apply part of the proceeds of this financing to payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. **The Ministry of Labour, Migration and Employment of Population** (“the Purchaser”) invites sealed bids from eligible Bidders for supply of **Equipment for International University of Tourism and Entrepreneurship in Khatlon Region** (“the Goods”). Delivery period is 90 days from Contract Signing Date.
3. Open competitive bidding - National advertisement will be conducted in accordance with ADB’s [Single-Stage: One-Envelope Bidding Procedure](#) and is open to all Bidders from eligible countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications defined in the Bidding Document may participate in this bidding:

Submission of audited financial statements or, if not required by the law of the Bidder’s country, other financial statements acceptable to the Purchaser, for the last <b>three (3)</b> years ( <b>2021, 2022, 2023</b> ) to demonstrate the current soundness of the Bidder’s financial position. As a minimum, the Bidder’s net worth for the last year calculated as the difference between total assets and total liabilities should be positive.	Successful completion as main supplier within the last <b>three (3)</b> years, of at least <b>two (2)</b> contracts each valued at <b>US Dollars Nine Hundred Sixty Thousand (US\$ 960,000)</b> with nature, and complexity similar to the scope of supply described in Section 6 (Schedule of Supply).	Minimum average annual turnover of <b>US Dollars Two Million Four Hundred Thousand (US\$ 2,400,000)</b> calculated as total payments received by the Bidder for contracts completed or under execution over the last <b>three (3)</b> years.
